### Membership guidelines:

PARBICA membership categories are based on those of the International Council on Archives (ICA). Prospective Category A and B members are required to become members of the ICA at the same level before joining PARBICA. Category C and D members are encouraged to join the ICA.

PARBICA offers the option of combining PARBICA and ICA membership invoices onto the one annual invoice for Category A, B and C members.

Membership is available to organisations and individuals residing in the Pacific. Members of the ICA located outside the PARBICA region may request membership of PARBICA as Category C members.
